

Welcome to use our products and services. We are well aware of the importance of personal information to you, and your trust is very important to us. We will strictly comply with legal requirements and take corresponding security measures to protect your personal information. Based on this, the TOC-0 service provider (or referred to as “we”) has formulated this “TOC-0 Privacy Policy” (referred to as “the policy”/“the privacy policy”) to help you fully understand how we collect, use, share, store, and protect your personal information and how you can manage your personal information in the process of using our products and services, so that you can make appropriate choices.

Before you start using our products and services, please read the policy carefully to ensure that you fully understand and agree before you start using them. If you have any questions, opinions, or suggestions about the content of the policy, you can contact us with the contact information at the end of the policy.

Your agreement to the privacy policy indicates that you understand the functions provided by the APP, as well as the necessary personal information required for the operation of the functions, and give corresponding authorization for the collection and use of personal information. However, this does not mean that you have separately agreed to enable additional functions or process non-essential personal information. For the opening of related additional functions, processing of non-essential personal information, and processing of sensitive personal information, we will separately seek your consent based on your actual use.

I. Scope of Application

The policy applies to various products and services provided to you by the TOC-0 service provider through websites and user terminals.

II. Information Collection and Use

Personal information refers to various information recorded in electronic or other ways that identify a specific individual or reflect specific activities of a specific individual, either alone or in combination with other information.

We only collect and use your personal information for the purposes described in the policy:

1. We do not sell or display any goods.
2. Conduct internal data analysis and research to improve our products or services.

We collect data based on your contract with us and the choices you make, including your privacy settings and the products and features you use. The data we collect may include SDK/API/JS code versions, browsers, internet service providers, IP addresses, platforms, timestamps, app identifiers, app versions, app distribution channels, unique device identifiers, MAC addresses, IMEI, device models, CPUs, network status, language locations, battery usage, etc.

When we use information for other purposes not stated in the policy, we will seek your consent in advance.

III. How We Share and Disclose Your Personal Information

A. Sharing

We will not share your personal information with any other company, organization, or individual unless the following circumstances occur:

1. Sharing with explicit consent: With your explicit consent, we will share your personal information with other parties.
2. We may share your personal information with third parties based on legal requirements or mandatory requirements from government authorities.

B. Disclosure

We will only disclose your personal information in the following circumstances:

1. After obtaining your explicit consent.

2. Based on legal disclosure: In cases of legal requirements, legal proceedings, litigation, or mandatory requirements from government authorities, we may publicly disclose your personal information.

IV. How We Protect Your Personal Information

1. We have implemented industry-standard security measures to protect the personal information you provide and prevent unauthorized access, disclosure, use, modification, damage, or loss of data. We will take all reasonable and feasible measures to protect your personal information.

2. We will take all reasonable and feasible measures to ensure that irrelevant personal information is not collected.

V. How the Privacy Policy Updates

We may adjust or change this privacy policy from time to time. Any updates to this privacy policy will be announced on our website with a marked update time. Except as otherwise provided by laws, regulations, or supervisory rules, the adjusted or changed content will take effect 7 days after notification or publication.
